## **Collective Marriage Notice - "Finally, married!" "Without Borders" Edition**

THE GENERAL PUBLIC DEFENDER, in the use of his legal powers, makes public that registrations are open for the Collective Marriage **"Finally, married!" – "Without Borders" Edition**, promoted in partnership with the Itinerant Justice Court of the Court of Justice of the State of Roraima, Operation "Acolhida", the Pastoral Service for Migrants of the Diocese of Roraima and the Loureiro Notary Offices - 1st Notary, Protest and Registration Office of Boa Vista/RR and Aquino - 2nd Office of Notes, Protest and Registration of Boa Vista/RR, intended for accomplish the marriage of 100 (one hundred) couples, in Boa Vista - Roraima, through a free relationship legitimization process, enabling couples to regularize marriage and family before the law, in addition to the full exercise of citizenship:

1. The Collective Marriage **"Finally, married!" – "Without Borders" Edition** is made up of:

1.1. **Civil Wedding and Ceremony**, which will be held on December 7th, 2023, at 4:00 pm, in the municipality of Boa Vista, at a location to be defined and announced posteriorly.

2. Requirements for couples to participate in the Collective Wedding **"Finally, married!" – "Without Borders" Edition** are:

2.1. That, at least, one of the applicants is an international migrant, residing in Boa Vista - Roraima and that both are over 16 (sixteen) years old;

2.2. Be single, legally divorced or widowers;

2.3. To have and present all documents described in item 3;

2.4. Declare that they do not have their own resources to cover the wedding expenses, without prejudice to their own livelihood or of their family;

2.5. There is no legal impediment to getting married, in accordance with article 1,521 of the Brazilian Civil Code;

2.6. Be aware of and agree with the entire contents of this notice.

3. Couples wishing to participate must register at the location, dates and times below:

**Location:** Civil Headquarters of the Public Defender's Office of Roraima, located at Avenida Sebastião Diniz, 1165 – Centro – Boa Vista – Roraima (near the bus integration terminal);

**Date:** October 2nd, 3rd, 4th, 9th, 10th and 11th, 2023;

**Time:** 2:00 pm to 5:30 pm.

**4.** When registering, the following documents must be presented:

**4.1. For applicants who are international migrants:**

**4.1.1. If they are over 18 (eighteen) years old:** National Migration Registry or protocol , CPF, Birth Certificate or identity card (ID card) or passport and proof or declaration of residence.

**4.1.2. If they are under 18 (over 16) :** In addition to the documents above, the presence of parents and/or legal representatives is required, who must carry the following documents: National Migration Registry or protocol, CPF, Birth Certificate or ID card and proof or declaration of residence;

**4.2. For applicants who are Brazilian:**

**4.2.1. If they are single :** ID card, CPF , Certificate in Birth and proof of residence;

**4.2.2. If they are divorced :** ID card, CPF, Marriage Certificate with the endorsement of the Divorce, mentioning the sharing goods and proof of residence.

If the divorce record does not mention the sharing of assets, it will be necessary to present a copy of the Divorce Deed, if carried out extra-judicially, or of the court sentence. If there was no division of assets in the divorce, the property regime cannot be partial communion of goods.

**4.2.3. If you are widowed :** Identity Card, CPF, Marriage Certificate, Death Certificate of the deceased person, proof in residence, Inventory of the assets left by the deceased person, or Negative Inventory.

If the Inventory has not yet been completed, they will be obliged to marry under the Separation of Property Regime.

**4.2.4. If they are under 18 (over 16 years old)** : Identity Card, CPF, Birth Certificate, presence of parents and/or legal representatives, who must present the following documents: ID Card, CPF and proof of residence.

**4.3.** Other documents may be requested at the time of registration to comply with the determination of the 1st Office Notary - Loureiro and the 2nd Office Notary - Daniel Aquino of the district of Boa Vista – RR.

**4.4.** For all couples, the presence of two witnesses who are of legal age will be required, who know to read and write, carrying ID card and CPF.

**4.5.** At the Marriage Collective **“Finally, Married!” – Edition “Without Borders”** it will not be possible the holding a wedding people with less of 16 (sixteen) years old or by power of attorney;

**5.** 100 (one hundred) couples will be enrolled and 20 (twenty) surplus couples will be registered to fill in any eventual withdrawals and/or registrations that do not meet the criteria established in this Notice. Once the vacancies are filled, the registrations will be closed, regardless of meeting the deadline specified in this Notice

**6.** Selection will be carried out in the order of registration and will only be carried out upon presentation of the complete and updated documentation (original, in perfect conditions, without erasures and one simple copy), according to the specifications in the item 3;

**7.** People who will be able to participate in the Collective Wedding **“Finally, Married!” – Edition “Without Borders”**: those people who wish to regularize their civil status, but do not have financial resources to defray the marriage, without prejudice in their sustenance or in their family.

**8.** The list of selected couples will be published on the website of the Public Defender's Office of the State of Roraima ([www.defensoria.rr.def.br](http://www.defensoria.rr.def.br)), as well as it will be fixed at the Mural of Civil Building from the Public Defender Public in Roraima and in the DPE-RR INSTAGRAM (@defensoriarr).

**9 .** The Public Defender's Office of Roraima will offer:

**9.1.** The collective civil marriage ceremony, with the possibility of the participation of religious ministers to promote a blessing to the couples;

**9.2.** The event photographic coverage with availability of the files (for download) by the couples, which will be available for 30 (thirty) days after carrying out the event.
